## Call to order

The meeting was called to order at 6:00 PM.

# **Approval of the Minutes**

Marty made a motion to approve the August meeting minutes. The motion was seconded by Roger. All present were in favor and the motion passed.

#### **New Business**

Banquet Preparation - Rick DuVall

While Dave was not present at the meeting, he asked for a decision on the banquet pricing so he can update the website. For reference, here are last year's costs:

Marty has a list of the menu options from German American Society and presented it to the Board. She will get back with them to find out cost for each of the options and bring it to the October Board meeting.

Nominations - Tom will send out notification for nominations on September 25th and give two weeks for input.

Awards - Marty needs three weeks to get the awards ordered once the nominations are in. Jacket orders - This will be completed once the fall tournament is complete.

#### Fall Tournament Bracket - Rick DuVall

Dave sent the Board a proposed bracket for the fall tournament. There are no objections to the layout so the Board determined that will be the one that will be used.

#### Bob Garcia Resignation - Rick DuVall

Bob will be leaving NSS and there will be a need to replace him for the remainder of his term. Mike was not present at the meeting and because he will be next commissioner, it will be his decision on how to fill the slot.

#### Player Ejection - Roger Clapper

There was a situation where a player was making disparaging remarks about the umpire but the umpire was unable to determine who the offender was so they could not throw out of the game. Roger's recommendation is that there is a rule indicating that if the person cannot be determined, the manager would be the one to be ejected from the game. This will be taken up for further discussion in the fall.

The website survey closed on 9/5 with the following results:

## Website visit frequency:

29% once a week 25% twice a week 44% three+ a week

### Website access:

43% computer
6% tablet
17% android phone
33% iphone

### Why you don't use the website:

"Don't like it" was the most useful of the three responses, which is a worthless response to the question.

## What would you like to see on the website:

### Useful comments, such as:

Adding a lost and found page - I'll look at adding something in the offseason

Better access to the yearly calendar - I don't get this as the calendar summary is one click from the front page

Advertising - this will be added in the offseason

Better mobile (cell phone) access - will work in the offseason

Help find tournament team info - it is there already, but tournament teams don't provide updates.

Make the log in button easier to find - this is more of a problem on cell phones, but will be worked in the off season

Player's phone numbers - already available via player's page, if the player allowed it to be shared

Helpful hints page - I'll look at adding something in the offseason, probably more of an unmoderated comment page.

RP Tool add player's positions - I can work with Chuck on this

New player feature - if someone interviews new players and provides me with something to post, I'll post it, but good idea

Financial report (quarterly, annually) - If the Dir of Finance provides me with something, I'll post it

More photos - If I get them, I'll post them. I understand that there used to be a place to flip through pictures. I may try to add a more automated photo scroll in the off season.

All players printable option - I'll talk with Chuck about this in the offseason

"I would like to see a posting on the front page, in BIG LETTERS, saying that anyone that loses equipment that does not have any sort of identification on it, causing the Communications Director to send out a "LOST & FOUND" message will be subject to a \$100 fee, payable to the Comminications Director. NO EXCEPTIONS!" - I wonder who wrote
